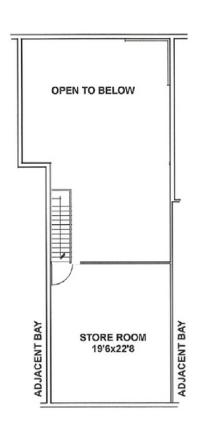
Floor Plan

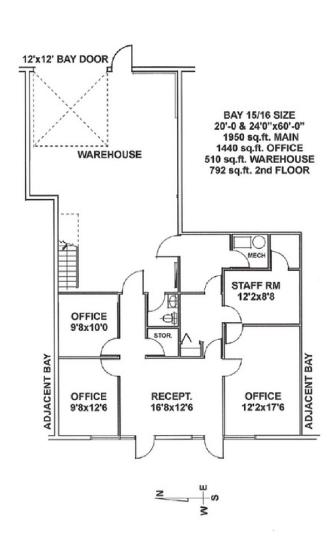

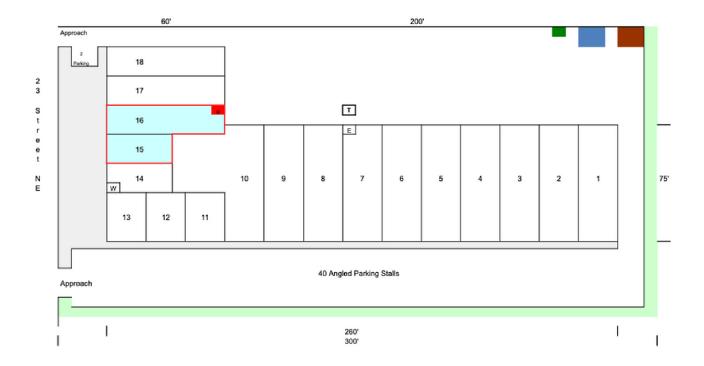
Site Plan

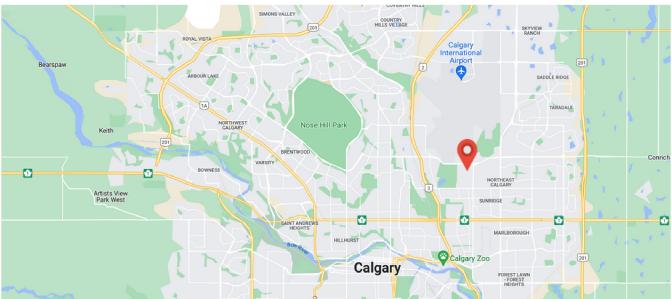
